PHASE ONE IS 13 WEEKS OF FORMAL PASTRY INSTRUCTION FROM A CURRICULUM DEVELOPED BY SUNFLOWER FOCUSING ON TECHNIQUES AND METHODS, KITCHEN AND FOOD SAFETY. PHASE TWO IS 13 WEEKS AND STUDENTS RECEIVE HANDS ON EXPERIENCE IN SUNFLOWER'S COMMERCIAL PRODUCTION KITCHEN UNDER DIRECTION OF CHEF INSTRUCTORS.
